




Tracing our Supply Chain

Traceability to Mill for PO Stream per IOI Location July2016-June2017






Traceability to Mill for PKO Stream per IOI Location July2016-June2017

The volumes from IOI owned mills are traceable to plantation level.


Twelve IOI mills are RSPO certified. We are preparing the remaining two mills for RSPO certification by end 2018.




Certified PO Volumes per Refinery July2016-June2017






Certified PKO Volumes per Refinery July2016-June2017





Risk Assessment and Supplier Verification & Consultation July2016-June2017



- o The risk assessment was performed by Proforest using the WRI / GFW tool.
- o Each mill was scored against 4 spatial parameters.
- o Mills are prioritized based on score risk assessment, volumes sourced and findings IOI's own mill alert system which includes spatial and non-spatial parameters.
